THE CRITERIA

The YOUNG LEADER OF THE YEAR Award Nominees must meet each of the following three criteria:

- Professional Leadership: Demonstrates excellence, creativity, and initiative in their business or profession.
- Community Leadership: Provides valuable service to Parke County through community involvement.
- Personal Leadership: Serves as a role model for Young Leaders both personally and professionally.

QUALIFICATIONS

- Nominees must be a Parke County resident.
- Nominees must have given extended service to the community and/or county in more than one area.
- Evidence of service to the community is considered important
- Nominees need not be members of the Parke County Chamber of Commerce.
- Nominees must be between the ages of 21-40 on or before December 31, 2018.
